

## **EVENT REGULATIONS WHISKY LIVE WARSAW**

- Organizer of the event "Whisky Live Warsaw" (hereinafter the "Event") is Tudor House company with its headquarters at Ludwinowska 1/37, entered into the registry of businesses conducted by the Regional Court for the Capital City of Warsaw, XIII Economic Department of the National Court Register with the number: KRS 0000041973, Taxpayer Id Number: NIP 5221000403 (hereinafter the "Organizer").
- 2. Whisky Live Warsaw fully promotes and supports responsible consumption of alcohol among all guests of the Event.
- 3. We recommend that the guests should eat before and during the Event.
- 4. We also recommend that the guests should drink plenty of water between tastings of alcohol and they should make regular breaks from the said tastings.
- 5. The Organizer provides free water during the Event. In order to ensure proper ambiance during the Whisky Live Warsaw festival. The exhibitors reserve right to refuse service to inebriated persons and the Organizer reserves right to remove such persons from the Event's premises without any right for re-entry.
- 6. In order to ensure proper ambiance during the Whisky Live Warsaw Event, the exhibitors reserve right to refuje service to inebriated persons and the Organizer reserves right to remove such persons from the Event's premises without any right for re-entry.
- 7. The Organizer reserves right, in connection with all resolutions and directives, which will be printed on the entry ticket or placed on a notice board at the Event's premises, to do the following:
  - 7.1. Refuse entry to a ticket holder when justified by safety concerns.
  - 7.2. Refuse to allow carrying into the Event's premises and using of:
    - 7.2.1. cameras or other devices for recording audio/video or a photographic camera with interchangeable optics, excluding compact amateur cameras and digital cameras up to 5 Mpix;
    - 7.2.2. musical instruments or any other devices and equipment which may be used for jamming the Event or in any other way make impossible to properly realize the Event according to its scenario;
    - 7.2.3. any and all sharp or dangerous objects, including, especially, items made of glass, metal or any other objects that the Organizer considers dangerous;
    - 7.2.4. weapons or explosive materials that may endanger health or life of the guests of the Event;
    - 7.2.5. flags or boards not directly-related to the Event or over 1 square meter (all banners must me rolled-up at request of the Organizer);
    - 7.2.6. foldable chair or touristic chair;
    - 7.2.7. food and beverages purchased outside the Event's premises;
    - 7.2.8. bringing any pets onto the premises of the Event;
    - 7.2.9. bringing in containers such as bottles, jars, vases, etc. that could be used by the guest for holding samales available at the exhibitors' stands.
- 8. Persons, who attempt to bring the above-mentioned items onto the Event, excluding items forbidden by law or any other items that the Organizer deems potentially dangerous for



the other guests of the Event, will be required to hand over the above-mentioned items to a deposit and to cover the deposit fees for the duration of the Event. In case a guest's belongings or clothes are discovered to contain weapons or Rother dangerous items, explosives, pyrotechnic articles or items creating a fire hazard Or narcotic drugs or psychotropic substances, the security personnel performing the check, apprehends the person by whom (in luggage or clothing) the items were uncovered and after confiscating above-mentioned items, creates a protocol describing the situation and, next, hands the person over to the Police together with the confiscated items.

- 9. It is forbidden to bring into Event premises and to utilize containers without proper markings that would enable collection of samples prepared by the exhibitors. In order to buy samples and to carry them outside the festival, the guests must purchase special containers in a designated place at the Event.
- 10. The guests who bring in containers that can be used to store samples handed out at the stands of the exhibitors will be asked to dispose of said containers under the pain of not being admitted to the Event.
- 11. During the Event, all bottles or other containers, containing alcohol and discovered by the staff will be confiscated; excluding containers prepared by the Organizer.
- 12. A deposit fee for a single item is 20 PLN.
- 13. The Organizer reserves exclusive right to refuse entrance to any person in breach to Any provisions of these Rules or laws in force.
- 14. The Organizer reserves right to request a ticket holder to vacate the Event's premises when justified by safety concerns and to undertake necessary steps for that to be realized. This is especially pertinent to situations where a guest disturbs public peace, behaves in an aggressive manner or fails to follow the Regulations of the Event.
- 15. "Guest of the Event" refers to an adult person participating in the Event on basis of an Id badge in form of a bracelet affixed on the wrist, issued in return of a valid ticket to the Event.
- 16. A person under 18 years of age may be present on the Event's premises without a need for a ticket and without having right to an Id badge, only under supervision of an adult who, when entering the Event for the first time, will sign a statement on assuming responsibility for the minor using a template provided by the Organizer. The template is available at the Event's website.
- 17. It is forbidden to undertake any activities of commercial nature or to fund-raise during the Event, without a prior direct written consent from the Organizer.
- 18. Official programmes and gadgets related to the Event will be sold solely at the Event's premises.
- 19. Organizer reserves right to cancel, shorten or change the scenario of the Event without prior notice to the guests of the Event.
- 20. If the Event is realized only partially, due to circumstances beyond Organizer's control, the Organizer will not be obliged to provide any compensation or damage payments to ticket holders apart remunerating the entirety or part of value of the ticket.
- 21. In case of change in dates, location or significant change in the programme, ticket holders may return their tickets before the start of the Event to receive a full return of its printed price.
- 22. In a situation, when due to the Organizer's decision the dates of the Event are changed, the tickets will be valid for the new dates of the Event.



- 23. The guests have no control competences toward the Organizer in relation to the ticket to the Event.
- 24. Organizer's liability in case of cancellation of the Event toward a given guest is limited to the value of the entrance ticket.
- 25. Access to Event's premises is granted to adult persons with an Id card and a ticket, which at first entering the Event's premises will be replaced with an Id badge. The tickets will be replaced with the Event Id badge upon the first entry to the Event. Repeated entry to the Event's premises will be granted only to guests with undamaged Id badge, affixed to their wrist. "Id badge" refers to the Identification badge issued by the Organizer at the entrance point of the Event in return for a ticket; The Identification badge will be a bracelet, affixed to the wrist, designed by the Organized; a given Id badge may be used by only a single person; damage or tearing of an Id badge voids its validity; it is forbidden to make the Id badge available to others.
- 26. A purchased ticked constitutes individual consent, on part of the Organizer, for a single person to enter the Event, which may be revoked at any time, due to a justified need to maintain the safety rules. This only entitles to return of the entirety or part of the price printed on the ticket, depending on whether the consent was revoked before entering the Event or during the Event. If the consent is revoked, in relation to the point above, due to causes on the ticket holder's side, the return of the ticket price will not be granted.
- 27. Tickets purchased for the Event may not be used in any advertising or promotional activities (including prizes in competitions or lotteries) nor for any other commercial or trade purposes by third parties, without a prior consent of the Organizer.
- 28. It is forbidden to re-sell a ticket at a price different than the one printed on the ticket under the pain of invalidity of the ticket without entitlement to seek remuneration of costs incurred in purchasing the said ticket.
- 29. According to provisions of Act on Consumer Rights, dated 30 May 2014, a person who purchased the ticket remotely or outside the company's premises, may return it in a period of up to 14 days without giving any justification and without incurring any costs.
- 30. The Organizer bears no material liability for any items brought by the guests to the Event's premises, which were not placed in the deposit.
- 31. During the Event, it is forbidden to present any slogans or scream aloud outcries of provocative nature nor outcries encouraging to breach of order and safety, nor outcries that may result in a conflict, nor anything defamatory nor discriminating others due to their sex, race, creed, age, opinions, political views, sexual orientation, belonging to Any subculture, sport preferences nor due to any other reason.
- 32. It is forbidden to block or stack anything against exits or evacuation routes, access roads for emergency services or hydrants or other equipment necessary in case of emergency actions or fire-fighting action during the Event.
- 33. By taking part in the Event, guests agree to have their likeness recorded by the Organizer in relation to realization of the Event and transfers to the Organizer all rights, without spatial or temporal limitations, to utilize their likeness and its recordings (photographic, audio-visual, audio) made during the Event.
- 34. By taking part in the Event, guests undertake to abide by these Regulations and are obliged to follow all orders of the safety and information staff as well as the Event staff and representatives of the Organizer.
- 35. Final interpretation of provisions in these Regulations are exclusive right of the Organizer.
- 36. The Organizer reserves right to change these Regulations.



37. The Regulations come into force on the day on which they are published and remain in force until the official end of the Event by the Organizer.
